**NO LOANER HELMETS AVAILABLE.**

**Fire Extinguishers:** If your car is STOCK, a fire extinguisher is recommended. If you have modifications to your car, a fire extinguisher is required. All fire extinguishers must have minimum rating of 5BC using a gauge showing full charge with a mounting bracket and strap that must be metal. Extinguisher must be within driver's reach when belts or harnesses are released.

Moral: Don't cheat, revenge can be nasty.
